SECTION 6: Accidental release measures

Personal precautions, protective equipment and emergency procedures: This material may burn, but will not ignite readily. Keep all sources of ignition away from spill/release. Stay upwind and away from spill/release. Avoid direct contact with material. For large spillages, notify persons down wind of the spill/release, isolate immediate hazard area and keep unauthorized personnel out. Additional Information (Reproductive toxicity): Di-isodecyl phthalate (DIDP) has been tested in two-generation reproductive toxicity studies. There were no effects on fertility or reproductive performance. A small but statistically significant decrease in offspring survival was observed. Developmental effects observed in the offspring, which included skeletal abnormalities, were judged to be secondary to maternal toxicity.

Toxicity: Experimental studies with rainbow trout, daphnia, and fresh water algae indicate that synthetic base oils are not expected to be harmful to aquatic organisms.

Persistence and Degradability: Synthetic base oils are not considered to be readily biodegradable but may be inherently biodegradable. They are expected to completely biodegrade over extended periods of time.

Bioaccumulative Potential: Not expected to bioaccumulate.

Mobility in Soil: Volatilization to air is not expected to be a significant fate process due to the low vapor pressure of this material. In water, this material will float and spread over the surface at a rate dependent upon viscosity. The main fate process is expected to be slow biodegradation of individual components in soil and sediment.

Other adverse effects: None anticipated.
